AGR Promotion Numbers for September 16 Promotions**

1. This MILPER message will expire not later than (NLT) 9 August 17.
  2. This MILPER message announces the promotion numbers for September 16. Military personnel divisions (MPD) should review current promotion lists and sequence numbers to determine individuals eligible for promotion in September 16. If a MPD receives a promotion order for an officer who is not eligible for promotion (e.g. flagged or separated), it must contact the officer promotions section point of contact (POC). Likewise, if the MPD does not receive an order for an officer who appears to be eligible for promotion, it must contact the officer promotions section POC.
  3. United States Army Reserve (USAR) Active Guard Reserve (AGR) Officers must be promoted on or before the date that the officer will complete the maximum years of service prescribed in Title 10, United States Code (USC), Section 14304. If at any time a USAR AGR officer on a standing promotions list cannot be promoted due to the aggregate strength-in-grade limitations of Title 10, USC, Section 12011, the officer may voluntarily leave the AGR program and accept a promotion in the higher grade (But not before the completion of maximum years of service prescribed in Title 10, USC, Section 14304), or the officer may remain on the promotion list in the current grade in an indefinite involuntary delay status per Title 10, USC, Section 14311(e). Promotions from subsequent boards will not ensue until officers previously selected for promotion in that competitive category are promoted.
  4. Human Resources Command (HRC), officer promotions, will announce the monthly officer promotions forecast in a MILPER Message at <https://www.hrc.army.mil/milper> and the promotion web page at <https://www.hrc.army.mil/Default.aspx?ID=5786> NLT the 15th of each month.
  5. The number promoted, sequence number promoted thru, and list promoted from for September 16 are reflected below.
